BBYO/Mandel JCC Annual Membership Terms & Conditions

This Membership Agreement ("Agreement") is between the Mandel Jewish Community Center ("MJCC") and the applicant(s) for membership identified on the front of this Agreement ("Member").

Eligibility

Cleveland Area BBYO members that are active and in good standing in grades 9th through 12th are eligible to join the Mandel JCC and receive the Mandel JCC/BBYO member rate and terms (8th grade BBYO members are eligible for membership as of January 1 of their 8th grade year). Teens must show photo ID (student ID, driver's license, etc.) at time of application to be eligible.

Membership Period

A BBYO membership runs from September 1 through August 31st of each year. BBYO members may join the MJCC at any time, however there are no prorated fees for BBYO members who join any time between September 1 and August 31.

BBYO Membership Restrictions

BBYO members are not eligible for member discounts on MJCC programs and services such as J-Day Camps, Camp Wise, Playmakers Youth Theatre, etc. Referral of a BBYO member to join the MJCC does not qualify for member referral offers or promotions occasionally advertised by the MJCC.

Changes to Membership Status

A BBYO Member may convert and/or upgrade to another membership category one time per year without incurring a processing fee (applicable Membership fees apply). If additional status changes are requested, processing fees will apply.

Cancellation/Termination

All new memberships are neither refundable nor transferable at any time during the membership period. Refunds cannot be issued for non-usage of the facilities.

Member Rules and Regulations

Members and their guests agree to abide by the policies and procedures outlined by the MJCC.

Revocation

The MJCC reserves the right to suspend or terminate the membership privileges of any member who fails to comply with the MJCC rules and regulations. Any member whose actions or behavior are determined to be improper will also have his/her membership terminated. The MJCC will notify the member of the cancellation in writing. Reinstatement of a member is subject to the approval of the Executive Director.

Membership Card

A valid MJCC membership card is required and must be shown to enter the building and use the MJCC facilities. There is a \$3 replacement fee for lost or stolen membership cards.

Photography

Unless otherwise specified in writing, members give permission for photos to be taken for future brochures, website, advertising, etc. and/or published without attribution on the MJCC website without compensation.

All terms, fees and conditions are subject to change. Other restrictions may apply.
