Enclosed please find a "fill-in-the-blanks" Parental Consent and Release form, which I believe is self-explanatory.

This form should be completed legibly and signed in blue ink, in the presence of a Notary Public, who should sign and date same also in blue ink, noting that if there is more than one parent/legal guardian, both should sign; and below all signature lines (including that of the Notary Public), each signatory should legibly print his or her name.

As to the Notary Public (noting that most banks and law offices have one on staff), given the possibility that a minor child could forge his parents' or legal guardians' signatures, I strongly recommend you not accept any form that has not been notarized; and, I otherwise strongly recommend you not permit participation by any child unless and until you are in actual receipt of a fully completed, signed and notarized Parental Consent and Release.

In that regard, although it is certainly preferable to have a "hard copy" original, if need be, your electronic receipt (via facsimile or email) should be legally sufficient.

The Congregation should retain the original fully completed and signed form and should provide a copy thereof to the parent(s) or guardian(s).
